

**Minutes of 34<sup>th</sup> Annual Meeting  
Southern Poultry Science Society  
January 29, 2013**

I. With close to 100 members present, President Don McIntyre called the meeting to order. The first order of business was the reading of the minutes from the previous meeting on January 24, 2012. It was moved to dispense with the reading of the minutes; the motion was seconded and passed with no discussion or dissenting votes.

II. Bob Buresh, Chair of the Audit Committee, presented the report of the Audit Committee. (Attachment 1). The committee offered special thanks to the sponsors for their support during these tough economic times.

It was moved that the report of the audit committee be accepted. The motion was seconded and passed with no discussion or dissenting votes.

III. Executive Secretary, Mary Beck, presented the financial report for the 2011-2012 fiscal year (Attachment 2).

The 2011-2012 Financial Report was reviewed. The beginning balance in all three accounts was \$66,683.32; the ending balance was \$74,799.06. Sponsor donations for the 2012 meeting were \$21,250. The net balance of the society increased by \$8,115.74 during the annual period of this report; FASS has not invoiced SPSS for the Science Advisory Committee (\$5000), so the increase is larger than it should have been. It is anticipated that SPSS will pay two years' support in 2013.

It was moved that the report be accepted as presented. The motion was seconded and passed with no discussion or dissenting votes.

- This year there was a total of 226 abstracts, 125 oral presentations and 100 posters; this is slightly lower than the 2012 total (261). There were 39 graduate student oral presentations and 20 posters in the student competition. There was 1 undergraduate oral presentation and 3 posters.
- Since U.S. Poultry & Egg Association is handling the registration, we do not get the final numbers until after the meeting; this year's registration is estimated to be around 1100, compared with 1258 last year and 780 in 2010.
